Cooperation Agreement

between

Separate Structural Subdivision of Higher Education Institution "Open International University of Human Development "Ukraine" Central Ukrainian Institute of Human Development, hereinafter referred to as CUIHD, and College of Management Edukacja in Wrocław Education, hereinafter referred to as WSE, confirming their interest in the development of cooperation in the field of research and teaching to their mutual advantage, have agreed as follows.

Art. 1

This Agreement sets out the purpose, terms and conditions of cooperation between WSE and CUIHD.

Art. 2

This Agreement pertains to teaching, research and student exchange.

Art. 3

Both Universities agree on the following forms of cooperation:

1. in the field of education:

- a) to exchange experience in teaching methods,
- b) to exchange staff members for the purpose of giving lectures, taking part in seminars etc.

2. in the field of research:

- a) to carry out joint research projects,
- b) to exchange scientific and technical information,
- c) to coordinate research studies,
- d) to exchange scientific results in specific fields of science,
- e) to publish the results in these fields,
- f) to organise joint seminars, conferences, symposia etc.

3. in the field of student exchange:

- a) to create conditions enabling students to take up undergraduate, postgraduate, uniform master's studies or PhD studies at a partner institution being a party to this agreement,
- b) to exchange students for a period of one semester or its part, or for a time needed to carry out a specific project, practical training or preparation of a thesis,
- c) to carry out joint research programmes by students,
- d) to exchange students under student traineeship schemes.

Art. 4

1. In order to achieve specific objectives and tasks under this Agreement, Parties shall sign a separate agreement which shall set out the terms and conditions of cooperation, in particular method of financing, time and period of the parties 'representatives' visits and intellectual property rights.
2. International Cooperation Centre at WSE shall be the contact point for the implementation of this Agreement.

Art. 5

1. The Parties agree to take necessary steps and ensure mutual support for the purpose of raising funds for the execution of this Agreement.
2. This Agreement does not entail any financial consequences for any Party.

Art. 6

1. This Agreement enters into force on the day of its signature and is concluded for 5 years.
2. If the Parties, at least 6 months before expiration of this period, do not initiate to extend it, this Agreement terminates.
3. The Agreement may be terminated upon a prior written notice of termination submitted by the 30th of June of the given year with effect at the end of that calendar year.
4. All amendments to this Agreement are null and void unless made in writing.
